EM has started CiLCA Course as agreed.

EM is chasing the Parish Steward for a schedule for the autumn and will release to Council when received.

EM will send out information on changes to National Planning.

EM gave an update on the fence at the Village Hall. There is a shortage of concrete posts at present. There have also been delayed due to Covid. The Council considered the option of using wooden posts rather than concrete. Council were happy to proceed with wooden posts if concrete posts continue to be unavailable.

FC20/21/057 TO DISCUSS AND AGREE NEXT STEPS REGARDING THE SPEEDING RESTRICTIONS WITHIN THE VILLAGE

The report done by a professional in 2012 was not acted upon. BT explained that there are three areas:

1. Lower Higher Street

The bends at the bottom of the high street tend to restrict drivers speed. A metro-count could be used (no charge). If the metro-count shows an average of < 25mph it is likely the speed limit could be lowered to 20mph. BT will look into getting a metro-count.

2. School Area



3. Marlborough Road

Originally the 30mph limit was proposed to be moved further out (as part of planning) but this did not happen. BT will talk to highways and see if this can be arranged (as per original planning agreements). A second metro-count could be arranged on the road. BT will look into this.

There is a 30mph sign on the right-hand side, from Marlborough, that is missing.

Council asked that an article be placed in the Dragon regarding parking on the Marlborough Road near the junction requesting residents to follow the highway code.

FC20/21/058 TO DISCUSS AND AGREE NEXT STEPS FOR THE PROVISION OF DOG WASTE BINS IN THE VILLAGE

EM had two additional quotations, one from Grist Environmental, the other from Hills. Collection charges for both were much higher than the original quotes obtained by BT.

Idverde quote was lower and included the provision of the bins. Emptying costs of £3.50 per empty.

Agreed to purchase a fixed bin and commence an agreement for emptying.

BT will contact Wiltshire Council to meet and discuss positioning of two bins. Jubbs Lane, between the garages and car-parking. EM will investigate the land ownership.

EM will investigate signage.
