# **Summary Of Public Participation Section**

# a) Report from Unitary Councillor

Cllr Davies invited Cllr Shepherd to speak.

Cllr James Shepherd introduced himself. Following the boundary changes for the forthcoming election, Cllr Shepherd will be running for Unitary Councillor for the area including Ogbourne St George.

Cllr Davies raised the speedwatch initiative (metro count) being run in Lockeridge which may be useful for Ogbourne. Cllr Shepherd mentioned that they had done similar in Aldbourne. There needs to be an average speed of 24mph or less to qualify for a reduction of speed limit.

Cllr Tanner stated that Ogbourne had achieved the 24mph target on the high street but not on the Marlborough road. Cllr Shepherd will discuss the option of running a joint initiative for the Ogbournes with Highways to assess if any cost-efficiency can be achieved.
